The Connecticut State Board of Examiners of Environmental Professionals (the Board) has received your request regarding the course titled "*Optimization and Monitoring for Bioremediation of Chlorinated Compounds*". Licensed environmental professionals (LEP) within the State of Connecticut must document every odd calendar year upon license renewal that they have met the CEC requirements set forth pursuant to section 22a-133v-2(e)(1) of the Regulations of Connecticut State Agencies (RCSA). This biennial period runs from July 1, 2017 through June 30, 2019.

After review of all the submitted materials, the Board has determined that the course fulfills CEC requirements pursuant to section 22a-133v-2(e) of the RCSA. However, the Board did not issue credit for the lunch guest speaker. Therefore, "*Optimization and Monitoring for Bioremediation of Chlorinated Compounds*" has been approved for **3.0 CECs** and is issued course number **CTLEP-468**.
